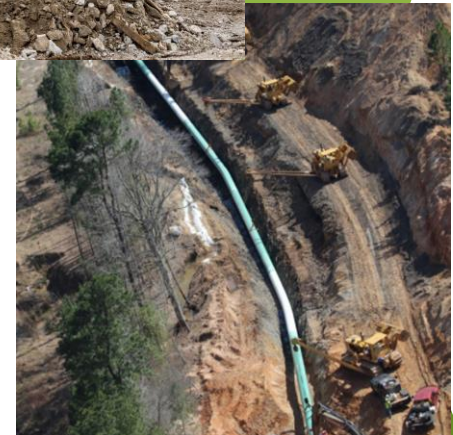

Scope

Purchase, then Renew and Replace (R+R) and Operate and Maintain (O&M) utilities for 50-year Period of Performance

Agency

Defense Logistics Agency - Energy (DLA-Energy)

Use Example 1:

Extract QASP, Contract, and SOW requirements for supporting transition and due diligence teams

Use Example 2:

Extract deliverables to support process builds, assignments, plans and SOPs
